


BASIS OF BEARINGS:
THE BASIS OF BEARINGS FOR THIS PLAT IS THE LINE BETWEEN THE NORTH 1/4 CORNER AND THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 6, TOWNSHIP 2 SOUTH, RANGE 1 WEST, UTAH SPECIAL BASE AND MERIDIAN WHICH BEARS SOUTH 89°02'58" EAST.

SURVEYOR NARRATIVE
THIS SURVEY WAS MADE AT THE REQUEST OF BUD WESS, FOR THE PURPOSE OF ESTABLISHING THE BOUNDARY FOR THE LOT OF THE SHARMEL ACRES SUBDIVISION DESCRIBED HEREON. THE EAST SIDE OF CORRAL ON THE LINE BETWEEN LOTS 12 AND 13 IS ALONG SAID LINE. REBAR WERE SET ON LINE FOR THE PURPOSE OF CONSTRUCTING A NEW FENCE.
