


**PROPERTY SURVEY FOR

DESCRIPTION

Beginning at the Northeast corner of the Northwest 1/4 of the Southwest 1/4 of Section 18, Township 1 South, Range 1 West of the Uintah Special Base and Meridian; Thence South 00°36'48" East 505.34 feet along the east line of said Northwest 1/4 to the north right-of-way of a gravel road; Thence northwesterly along said right-of-way the following 4 courses:
 North 87°20'03" West 131.09 feet;
 North 79°39'03" West 73.18 feet;
 North 73°16'51" West 150.15 feet;
 North 71°01'40" West 251.24 feet to the extension of the property line fence of that parcel described on page 552, Book A313 of deeds on file in the Duchesne County Recorder's office;
 Thence North 01°28'59" East 366.28 feet along said property line fence and extension thereof to the north line of said Northeast 1/4;
 Thence South 89°30'02" East 569.46 feet along said North line to the POINT OF BEGINNING, containing 6.01 acres. Together with an ingress-egress easement along an existing road the centerline of which is further described as follows:
 Beginning at a point on the West line of said NW1/4, said point being South 407.62 feet from the West Quarter Corner of said Section;
 Thence North 86°07'40" East 631.91 feet;
 Thence South 73°22'58" East 343.06 feet;
 Thence South 72°57'36" East 171.38 feet;
 Thence South 79°39'03" East 75.24 feet;
 Thence South 87°20'03" East 133.06 feet to the East line of said NW1/4.

NARRATIVE

This survey was performed at the request of Mr. Steven Duncan in order to divide out a parcel of land as shown on this plat. The north and east lines were determined by the quarter-quarter section lines. The south was established along the North right-of-way line of an existing gravel road. The location of the west line was determined to be along an old existing property line fence along the east line of that parcel described on page 552, Book A313 of deeds on file in the Duchesne County Recorder's office. All monuments found and used for this survey are as shown.
