DESCRIPTION OF PARCEL IN SECTION 10
Beginning at the Southeast Corner of Section 10, Township 1 South, Range 8 West of the Uintah Special Base and Meridian;
Thence South 89°54'38" West 400.26 feet along the South line of the SE¼ of said Section to an existing fence;
Thence the following eight courses along said fence and extension thereof:
North 17°33'33" West 325.41 feet;
North 11°57'03" East 59.46 feet;
North 41°13'37" East 18.32 feet;
North 46°58'23" East 157.60 feet;
North 37°05'39" East 32.35 feet;
North 24°58'51" East 12.35 feet;
North 36°22'24" East 45.80 feet;
North 18°15'39" West 108.22 feet, more or less to the centerline of the Duchesne River;
Thence South Southeasterly 423 feet, more or less along said centerline to the East line of said aliquot part;
Thence South 0°02'29" West 426.72 feet along said West line to the Point of Beginning, containing 5.247 acres.

Thence Southeasterly 875 feet, more or less along said centerline to the extension of an existing fence;
Thence South 32°50'32" West 200.04 feet along said fence and extension thereof;
Thence South 29°02'28" West 158.07 feet along said fence;
Thence South 29°03'56" West 407.84 feet along said fence;
Thence South 29°03'56" West 260.56 feet along said fence and extension thereof to the South line of said aliquot part;
Thence South 89°50'55" West 167.63 feet along said South line to the Point of Beginning, containing 12.349 acres.

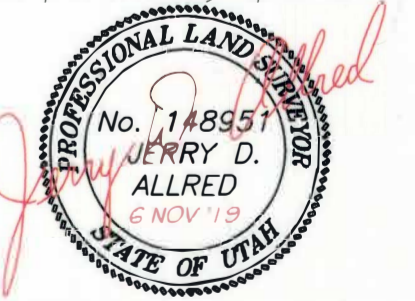
