

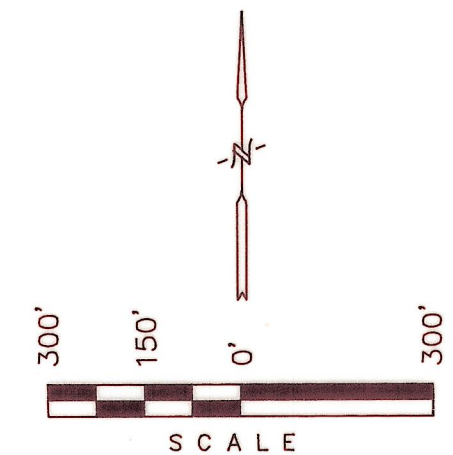

WHICH BEARS N65°36'23"W 3817.63' FROM THE SOUTHEAST CORNER OF SAID SECTION, THENCE N56°55'53"E 702.16'; THENCE N54°21'17"E 1153.93' TO A POINT ON THE SOUTH LINE OF THE NE 1/4 OF SECTION 8, WHICH IS COMPUTED FROM G.L.O. INFORMATION TO BEAR N89°40'58"W 1948.42' FROM THE EAST 1/4 CORNER OF SAID SECTION 8. THE SIDE LINES OF SAID DESCRIBED RIGHT-OF-WAY BEING SHORTENED OR ELONGATED TO MEET THE GRANTOR'S PROPERTY LINES. SURVEYOR'S NARRATIVE

WE WERE REQUESTED BY ANR PRODUCTION COMPANY TO SURVEY THE PIPELINE RIGHT-OF-WAY FOR THE ELLSWORTH #2-8B4 WELL SITE. AS CONTROL FOR THIS SURVEY WE USED THE SECTION CORNERS AS SHOWN HEREON. THE POSITIONS OF THE PROPERTY LINES BETWEEN LAND OWNERS WERE COMPUTED USING FIELD MEASUREMENT AND G.L.O. INFORMATION.

AS BASIS OF BEARINGS FOR THE SURVEY WE ASSUMED THE G.L.O. BEARING OF N0°03'W ALONG THE EAST LINE OF THE SE 1/4 OF SECTION 8, T2S, R4W, U.S.B.&M.
