
SURVEYOR'S CERTIFICATE

NARRATIVE

PURPOSE OF SURVEY: The purpose of this survey was to establish the boundary lines of the Robert Delyle Giles property and to set permanent markers at the property corners as shown.

BASIS OF BEARING: The basis of bearing was assumed to be North 89°54' East from the Northwest corner of Section 4 to the North ¼ corner of Section 4, as per the G.L.O. Survey of 1903.

SURVEY FINDINGS: The 40 acre lines were determined by conventional methods of section breakdown. The section corners and ¼ corners were determined from previous surveys in the area. (See Gordon Vantassell Survey on file in the Duchesne County Surveyor's office)



