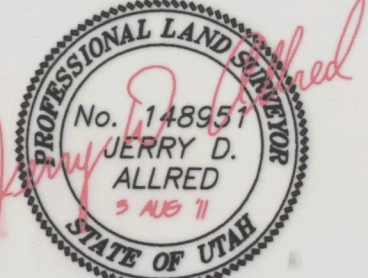
THE PIPELINE SHOWN IS THE CENTERLINE OF A 40 FEET WIDE RIGHT-OF-WAY.
