

A 30' WIDE RIGHT-OF-WAY LOCATED IN SECTION 31, T2S, R3W, U.S.B.&M. ALSO, IN SECTIONS 5 & 6, T3S, R3W, U.S.B.&M. THE WIDTH OF SAID RIGHT-OF-WAY BEING 15' ON EACH SIDE OF THE CENTERLINE. THE CENTERLINE OF SAID RIGHT-OF-WAY BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
BEGINNING AT A POINT IN THE SE 1/4 SE 1/4 OF SECTION 31, T2S, R3W, U.S.B.&M. WHICH BEARS N59°10'11"W 1521.50' FROM THE SOUTHEAST CORNER OF SAID SECTION 31, THENCE S56°54'31"W 321.78'; THENCE S72°31'58"W 184.10'; THENCE S47°50'13"W 111.44'; THENCE S03°01'56"W 104.28'; THENCE S34°22'47"E 121.40'; THENCE S35°00'04"E 111.66'; THENCE S22°39'05"E 180.86'; THENCE S18°47'18"E 156.68' TO A POINT ON THE NORTH LINE OF SECTION 6, T3S, R3W, U.S.B.&M. 
