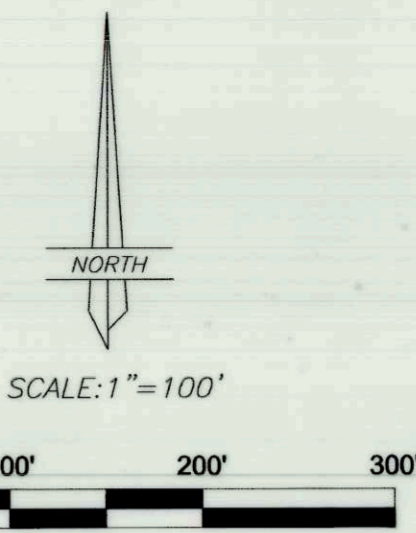


RIGHT-OF-WAY SURVEY FOR

THIS SURVEY WAS PERFORMED USING GLOBAL POSITIONING SYSTEM PROCEDURES AND EQUIPMENT

THE BASIS OF BEARINGS IS GEODETIC NORTH DERIVED FROM G.P.S. OBSERVATIONS AT A CONTROL POINT LOCATED AT LAT. 40°10'43.26237"N AND LONG. 110°23'52.06157"W USING THE UTAH STATE G.P.S. VIRTUAL REFERENCE STATION CONTROL NETWORK MAINTAINED AND OPERATED BY THE AUTOMATED GEOGRAPHIC REFERENCE CENTER

NARRATIVE

The purpose of this survey is to describe and locate the two sixty-six feet wide roadway and utility easements serving the Duchesne County property in Section 31 as shown on this plat. The monuments marking the Public Land Survey System (PLSS) corners were found as noted and were used to control this survey. Said corners have been accepted as either the original section subdivision corners or a perpetual representation of the original corners as set and accepted by the General Land Office. All monuments found and used for this survey are as noted at their respective locations on this plat.

DESCRIPTION OF RIGHT-OF-WAY #1

A 66 feet wide roadway and utility easement and right-of-way on portions of Section 31, Township 3 South Range 4 West of the Utah Special Base and Meridian, said right-of-way being 33 feet on each side of the centerline which is further described as follows:
Commencing at the SW Corner of the NW1/4 of said Section 31; Thence North 00°05'16" East 1618.54 feet along the West line of said NW1/4 to the TRUE POINT OF BEGINNING;
Thence South 89°54'49" East 866.92 feet to the point of terminus. Said described right-of-way being 866.92 feet in length, with the sidelines being shortened or elongated to intersect existing right-of-way lines.

DESCRIPTION OF RIGHT-OF-WAY #2 (C.R. 20830W)

A 66 feet wide roadway and utility easement and right-of-way on portions of Section 31, Township 3 South Range 4 West of the Utah Special Base and Meridian, said right-of-way being 33 feet on each side of the centerline which is further described as follows:
Commencing at the SW Corner of the NW1/4 of said Section 31; Thence North 60°40'38" East 995.17 feet to the TRUE POINT OF BEGINNING, with a bearing of North 00°05'16" East between said SW Corner of said NW1/4 and the NW Corner of said Section 31 being the basis of bearings; Thence North 00°05'16" East 2166.89 feet to the North line of said NW1/4, which is the point of terminus. Said described right-of-way being 2166.89 feet in length with the sidelines being shortened or elongated to intersect existing right-of-way lines and said North line of said aliquot part.

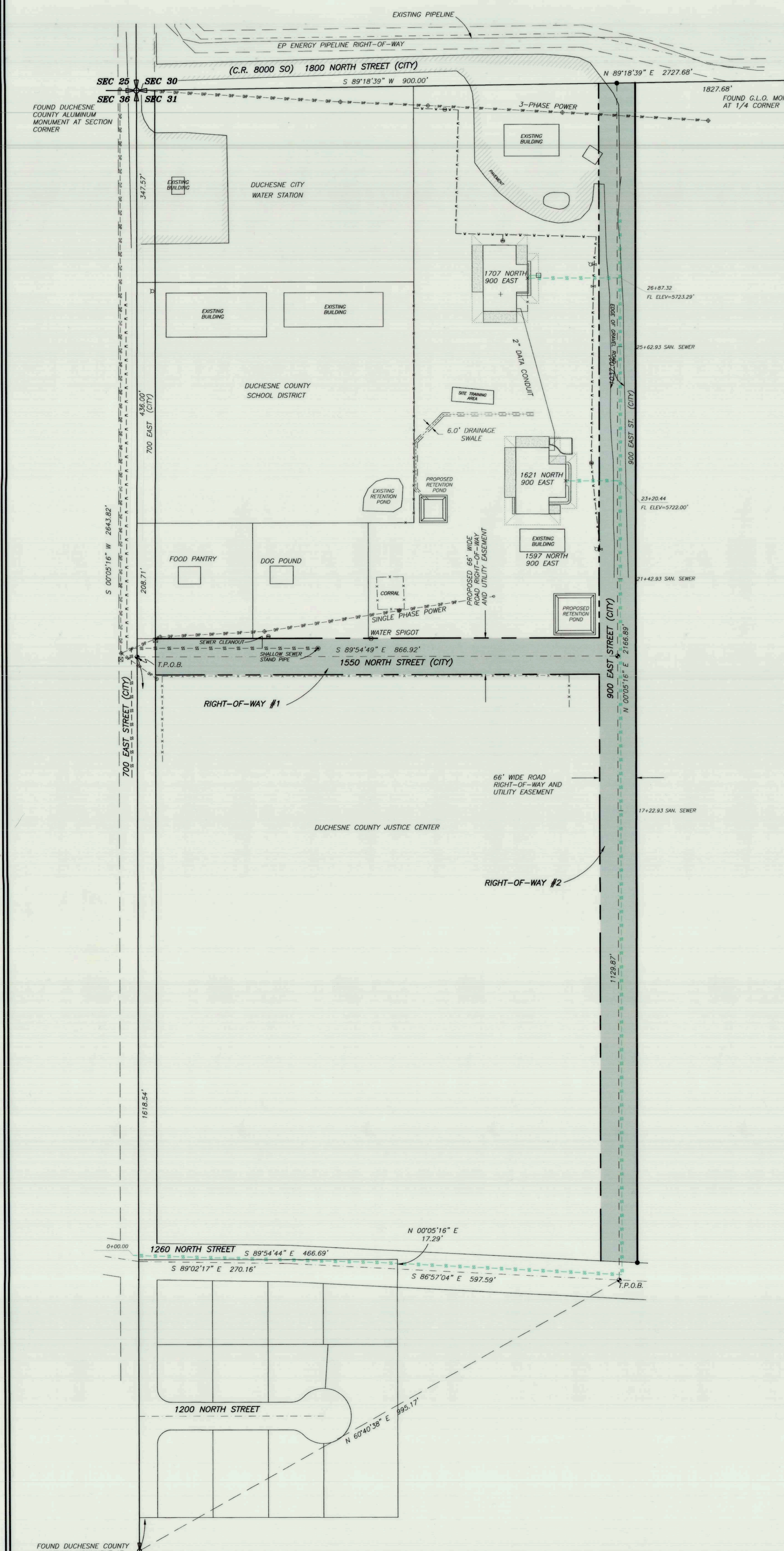
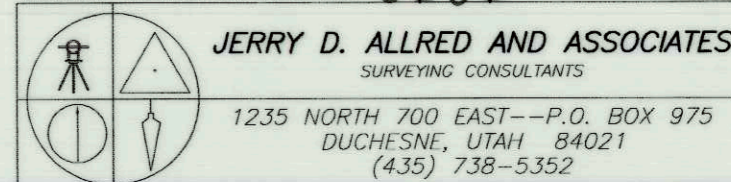
